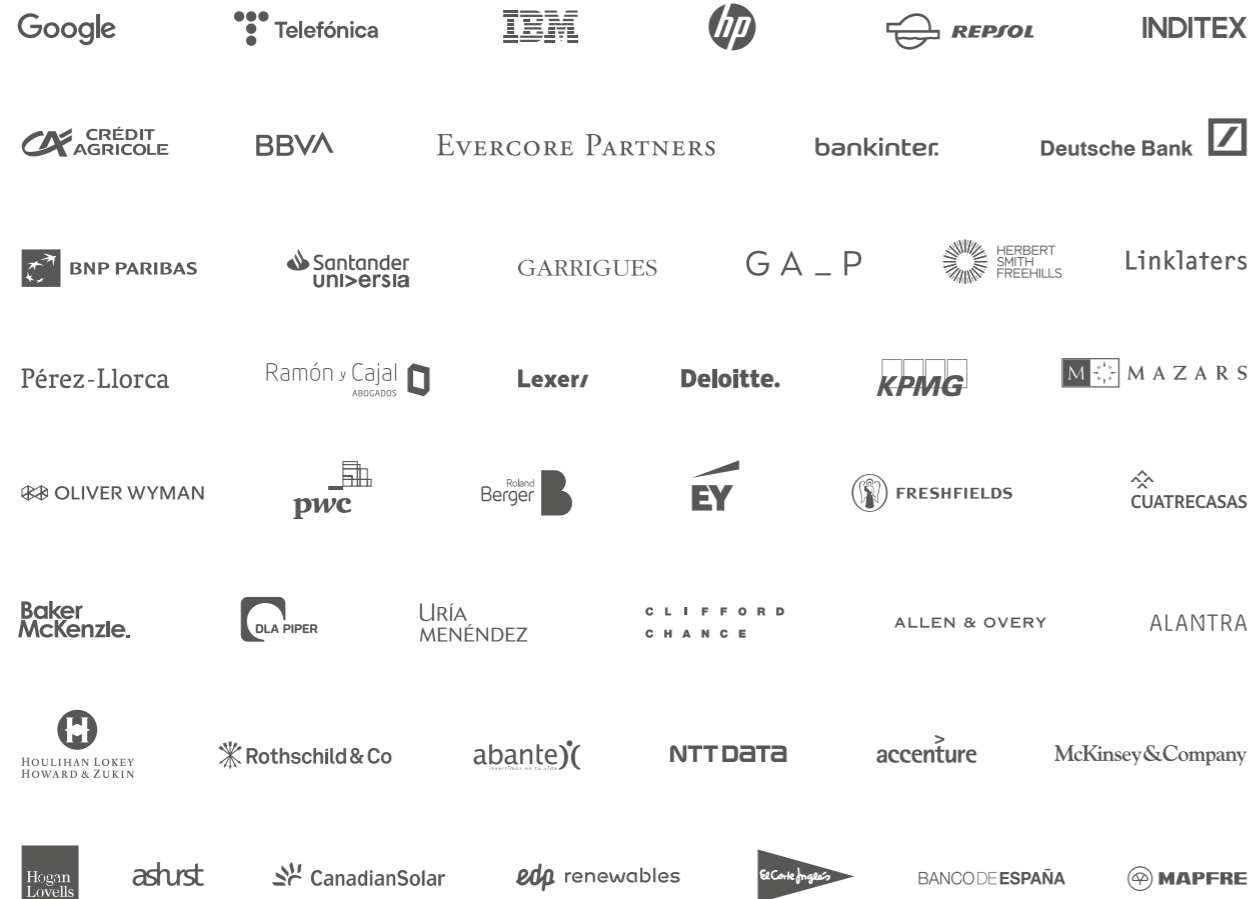

SCHOLARSHIP AND FINANCIAL AID PROGRAMME



To succeed in a master programme, participants must be dedicated, active, and committed to achieving excellent academic and professional results. At CUNEF, we pay special attention to participant quality in each of our programmes, to ensure that the best candidates enrol in our graduate degrees.

CUNEF Universidad, supported by **FAEB (Spanish Banking Association Foundation)**, has in place a scholarship and financial aid programme for new-entry students to reward and promote academic excellence and facilitate access to higher education.

Partial Grants

They are aimed at university graduates (who finished their degree no more than five years before the start of the graduate programme). The amount awarded will range between 10% and 50% of the price of CUNEF Universidad's master programme.

FAEB Scholarships for Academic Excellence

They are aimed at new-entry students admitted into a graduate programme at CUNEF Universidad who can accredit a track record of academic excellence.
